## REPORT OF THE EXECUTIVE COMMITTEE MEETING

The AIPA Executive Committee (EXCOM) meeting convened on Monday, $15^{\text {th }}$ September 2014 from 8 p.m. to 9.30 p.m. to prepare the agenda and programme of the $35^{\text {th }}$ General Assembly (GA) of AIPA.

## Attendance

1. Pursuant to Chapter 4 Article 8 of the AIPA Statute, the President of AIPA shall be the Chairman of the Executive Committee. The EXCOM meeting was chaired by H.E. Madam Pany Yathotou, President of AIPA/President of the National Assembly of Lao PDR.
2. The EXCOM was attended by delegations from AIPA Member Parliaments. The Delegations from Legislative Council of Brunei Darussalam is led by H.E. Mr. Pehin Dato Isa bin Ibrahim; the National Assembly of the Kingdom of Cambodia is led by by H.E. Samdech Akka Moha Ponhea Chakrei Heng Samrin ; House of Representatives of the Republic of Indonesia is led by Hon. Dr. Surahman Hidayat; the National Assembly of Lao People's Democratic Republic is led by Hon. Dr. Saysamphone Phomvihane; the Parliament of Malaysia is led by H.E. - The EXCOM acknowledged the nomination of Dr. Nurhayati Ali Assegaf as candidate for President of Inter-Parliamentary Union (IPU) 2014-2017.
- The EXCOM agreed to postpone to the next General Assembly of AIPA and the proposed topic by the Representative of Indonesian Delegation namely "The Adoption of National Action Plans to Implement the United Nations Guiding Principles on Business and Human Rights and Reaffirm the State's Duty to Protect".
