**BE IT RESOLVED**; that each APPU member country take steps to address the decline of highly migratory fish stocks and to preserve the health of highly migratory fish stocks at sustainable levels; and

**BE IT FURTHER RESOLVED** that certified copies of this resolution be transmitted to the members of the Asian Pacific Parliamentarians' Union.

### RESOLUTION

To promote use of existing carbon trading mechanisms to implement projects to reduce emissions in developing and developed countries; and to encourage information sharing about alternative energy programs to carry out the intent of existing resolutions

WHEREAS, each APPU member country has an interest in studying alternative energy sources that will reduce each country's dependence on imported fossil fuels and avoid adverse environmental effects; and

WHEREAS, the Kyoto Protocol's Clean Development Mechanism allows developed countries to gain emissions credits for implementing emission reduction projects based in developing countries; and

WHEREAS, through the Kyoto Protocol's Joint Implementation, one developed country can receive emissions credits for implementing projects that reduce emissions in another developed country; and

WHEREAS, each APPU member country has resolved to cooperate in alleviating global warming; and

WHEREAS, each APPU member country has resolved to cooperate in environmental management, including the protection of shorelines and reefs; and

WHEREAS, each APPU member country has resolved to investigate alternative energies, including Ocean and Thermal Energy and wave energy; and

WHEREAS, the APPU is especially suited to facilitate information sharing about programs that could carry out these resolutions and support larger countries' use of Kyoto Protocol mechanisms for alternative energy and emissions reduction projects in other countries;

### NOW THEREFORE,

**BE IT RESOLVED**; that each APPU member country take steps to share information and to facilitate use of Kyoto Protocol mechanisms to enable informational and financial support for alternative energy-investigation, global warming alleviation, and environmental management programs; and

**BE IT FURTHER RESOLVED** that certified copies of this resolution be transmitted to the members of the Asian Pacific Parliamentarians' Union.
